**ACADEMIC INTEGRITY AND RESEARCH ETHICS POLICY-2018-2021**

**NOTE:** This policy statement is based on the notification issued by the University Grants Commission on 23rd July, 2018 entitled 'UNIVERSITY GRANTS COMMISSION (PROMOTION OF ACADEMIC INTEGRITY AND PREVENTION OF PLAGIARISM IN HIGHER EDUCATIONAL INSTITUTIONS) REGULATIONS, 2018' Ref: F. 1-18/2010(CPP-II).

As per the UGC guideline and notification "Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions" Regulations, 2018, the faculty, students and research scholars are required to have ethical and moral values for academic pursuit. Plagiarism has become a serious problem during current ICT era. The Plagiarism Policy of Govt. D.B. Girls' P.G. College, Raipur (Autonomous) has been formulated with a view to ensure no plagiarism in the research work that is carried out by its faculty, researchers or students in the form of thesis, dissertation and publication of research papers, chapters in books, full-fledged books and/or any other similar work.

**OBJECTIVES**

- i. To create awareness about responsible conduct of research, thesis, dissertation, and promotion of academic integrity and prevention of misconduct including plagiarism in academic writings among students, faculty, researchers and the staff.
- ii. To establish institutional mechanism through education and training to facilitate responsible conduct of research, thesis, dissertation, and promotion of academic integrity and deterrence from plagiarism.
- iii. To develop systems to detect plagiarism and to set up mechanisms to prevent plagiarism, all Ph.D. supervisors of the college registered in URKUND.

## REGULATORY AUTHORITY

College Level Academic Integrity and Ethical Committee (CAIEC) Composition for College Level Research/PhD Programmes

1. Chairperson – Principal
2. Organising Secretary
3. Member – Senior Academician(s) from each Faculty nominated by the Principal.
4. Member – Member(s) nominated by the Principal as experts from outside the College
5. Member – Member(s) anti-plagiarism experts nominated by the Principal.
6. Member – Member representative from the student body nominated by the Principal.

## FUNCTIONS AND POWERS

- (a) The Chairperson of the CAIEC shall be the Principal of the College.
- (b) The tenure of the Committee members shall be for five years, with the exception of the Student Representative.

The CAIEC shall investigate cases of plagiarism as per the provisions mentioned in these regulations. (c) The CAIEC shall provide a copy of the report to the person(s).
